#### **Data Release and Application Updates**

Due to Governor Baker's emergency actions to limit the spread of COVID-19 CHIA's workforce will be remote, for now, until April 6th. This arrangement will limit CHIA's ability to produce and deliver data extracts. At this time it is unknown when CHIA will be able to fulfill data requests but CHIA is exploring alternative data delivery options in order to maintain business as usual. CHIA will continue to do its best to limit the impact of our energy response to data requestors.

During this time, CHIA will continue to accept and review data applications for both Case Mix and All-Payer Claims Database (MA APCD) datasets. Review committees, DRC and DPC, will continue their meetings remotely as necessary.

Due to CHIA's physical office being closed, applications will be accepted without a fee. After receipt of the application, CHIA will issue an invoice which will allow applicants to remit payment online.

If you are a Data User that has a CHIA hard drive in your possession, please keep the hard drive at this time while CHIA's physical office is closed.

### **APPLICATION REMINDERS**

#### **Fee Waiver Request Reminders**

- If you're submitting a request for a fee waiver, remember to include the fee remittance form in your application package on IRBNet.
- 2. Remember to submit supporting documentation (if required).
- 3. If you're requesting a financial hardship waiver, remember to submit information detailing your project's financial situation (examples: project budget, grant funding, organizational / departmental funding). Also request to pay a specific price that you reasonably believe you're able to afford to contribute.
- 4. CHIA generally does not offer full financial hardship fee waivers. We expect all applicants to have made an attempt to find funding to cover the full cost of the data fees.
- Fee waiver requests can take some time to process especially financial hardship requests.



## **USER QUESTIONS**

Question: Since the transition from ICD-9-CM to ICD-10-CM has there been any improvement in the completeness of cause of injury coding in the MA APCD. Historically, we have used the case mix outpatient emergency department data and inpatient hospital discharge data for injury and poisoning surveillance due to the high completeness (over 90%) of cause codes associated with injury diagnosis.

<u>Answer</u>: To answer your question, we compared injury claims in two different versions of the MA APCD containing ICD-9-CM and ICD-10-CM.

**STEP 1:** We determined the percent of MA APCD Release 5.0 highest version medical claim lines for Massachusetts residents with a principal diagnosis code of injury or poisoning (ICD-9-CM 800-999) accompanied by an external cause of injury code (E-code) in the designated E-code field or any associated diagnosis field for a 4-year ICD-9-CM period (CY2011 through CY2014).

**STEP 2:** We compared the percent of MA APCD Release 5.0 injury claims with a cause of injury code to the percent of MAAPCD Release 7.0 with an principal diagnosis injury or poisoning code range (ICD-10-CM S00-S99, T00-T88) accompanied by a cause code (V00-Y89) in the

cause field or any associated diagnosis field.

RESULTS: During the ICD-9-CM period, 12% of injury claims had a cause diagnosis. After ICD-10-CM implementation, there was a significant increase in cause coding to 19% of injury claim lines having a

cause code. See table 1 below.

# Question: What is day's supply (PC034)? How is it determined and why are there sometimes negative values?



#### **Answer:**

Day's Supply is defined as the number of days a prescription will last if taken as prescribed.

- Quantity Limits define how much of a drug you can fill during a specific time period. Different limits apply to different drugs.
- Insurance plans use quantity limits to ensure patient safety and control costs
- Usually, plans review clinical and FDA literature to decide how much of a drug they will cover in a certain time period.
- Not all prescriptions have quantity limits, but many do based on the following reasons:
  - 1. They are FDA approved only for short-term use
  - 2. They may cause side effects when overused
  - 3. They carry the risk of being inappropriately overused

Negative values are associated with claims reversal, for example, instances when a patient does not pick up a prescription that has been prepared.


