VERSION 3.0 VARIANCES

- CONDITIONAL ELEMENT VARIANCES

CONDITIONAL ELEMENT VARIANCES

VERSION 3 EDITS ON FIELDS WITH CONDITIONAL REQUIREMENTS RUN AGAINST LINES THAT MEET THE CONDITION
PERCENT PASSED IS BASED ONLY ON LINES THAT MEET THE CONDITION

VERSION 2 EDIT IGNORED CONDITIONAL REQUIREMENT AND BASE WAS FULL FILE

Vers 2

1000 lines, 100 are IP – Edit runs against all lines, the 100 are appropriately filled in for IP the 900 are blank – the edit & FER show 10% passed.
A variance of 10% was needed.

Vers 3

1000 lines, 100 are IP – Edit runs against 100 lines, the 100 are appropriately filled in for IP the 900 are blank – the edit & FER show 100% passed.
No variance is needed.

Or

1000 lines, 100 are IP – Edit runs against 100 lines, 75 are appropriately filled in for IP the 925 are blank – the edit & FER show 75% passed
If this is typical due to their book of business they need a 75% variance.

CONDITIONAL ELEMENT VARIANCES

VERSION 3 EDITS ON FIELDS WITH CONDITIONAL REQUIREMENTS RUN AGAINST LINES THAT MEET THE CONDITION
PERCENT PASSED IS BASED ONLY ON LINES THAT MEET THE CONDITION

VERSION 2 EDIT USED CONDITIONAL REQUIREMENT BUT BASE WAS FULL FILE

Vers 2

1000 lines, 100 are IP – Edit runs against all lines, 90 are appropriately filled in for IP the 910 are blank – the edit & FER show 99% passed.
No variance was needed.

Vers 3

1000 lines, 100 are IP – Edit runs against 100 lines, 90 are appropriately filled in for IP the 910 are blank – the edit & FER show 90% passed.
A variance of 90% is needed

CONDITIONAL ELEMENT VARIANCES FIELD EDIT REPORT EXAMPLE

Version 2 and Version 3 of ME111 (Medical Deductible) had a 90% requirement when ME018 (Medical Coverage) = 1 (Yes).
